Kynar Finish Option Limited Warranty

Overhead Door Corporation ("Seller") warrants to the original purchaser of the **Overhead Door brand Thermacore Series 591, 592, 593, or 594 commercial sectional insulated door with applied Trinar (Kynar) finish option** (the "Product"), that the finish on Product sections with applied Trinar (Kynar) finish will be free from defects in materials and workmanship under normal use as follows:

Seller warrants that for twenty (20) years after the date of installation of the Product, the Trinar® (Kynar) finish on the Product sections will not:

- Crack, peel or check causing separation of the paint from the Product sections (except for slight crazing or cracking as may occur on normal roll-forming or brake bending and which is accepted as standard such crazing or cracking shall not constitute a basis for complaint under this limited warranty).
- Chalk in excess of a numerical rating 8 using the procedures of ASTM D-4214-89 (Method D-659);
- Fade or change color in excess of 5 E units (Hunter Color Difference) according to ASTM D-2244-85 comparing an
 unexposed retain sample to the exposed section after removal of dirt and chalk.

Seller's obligation under this warranty is specifically limited to repainting (exterior only) or replacing, at its option, the affected Product section(s) which shall be determined by Seller to be defective during the applicable twenty (20) year warranty period. Any labor charges are excluded and will be the responsibility of the purchaser.

This warranty is made to the original purchaser of the Product only and is not transferable or assignable. This warranty does not apply to any unauthorized alteration or repair of the Product, or to any Product or component which has been damaged or deteriorated due to misuse, neglect, accident, failure to provide reasonable maintenance, normal wear and tear, or acts of God or any other cause beyond the reasonable control of Seller. This warranty does not apply to any damage or deterioration caused by exposure to salt water, chemical fumes or other corrosive or aggressive environments, whether naturally occurring or man-made, including, but not limited to, environments with a high degree of humidity, sand, dirt or grease. This warranty does not apply if the Product is installed within 2000 meters of any ocean or other body of saltwater. This warranty specifically excludes any damage resulting from scratching, abrasion or impact by any hard object, and any fading or color change which may not be uniform due to unequal exposure of the sections to sunlight or other elements.

THE ABOVE WARRANTIES ARE EXCLUSIVE AND IN LIEU OF ANY OTHER WARRANTIES, EITHER EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OF FITNESS FOR A PARTICULAR PURPOSE.

IN NO EVENT SHALL SELLER BE RESPONSIBLE FOR, OR LIABLE TO ANYONE FOR, SPECIAL, INDIRECT, COLLATERAL, PUNITIVE, INCIDENTAL OR CONSEQUENTIAL DAMAGES, even if Seller has been advised of the possibility of such damages. Such excluded damages include, but are not limited to, loss of good will, loss of profits, loss of use, cost of any substitute product, interruption of business, or other similar indirect financial loss.

Claims under this warranty must be made promptly after discovery, within the applicable warranty period, and in writing to the Seller or to the authorized distributor or installer whose name and address appear below. The purchaser must allow Seller a reasonable opportunity to inspect any Product claimed to be defective prior to removal or any alteration of its condition. Proof of purchase and/or installation date, and identification as the original purchaser, may be required.
